Product Application

Remove wipe from packaging container. Use wipe to clean down desired surface. Dispose of wipe once it becomes too dirty or is completely dry.

Directions for use:

1. Remove lid. Peel off foil seal.
2. Pull wipe from centre of roll and feed through lid.
3. Replace lid. Pull wipe out and tear off at perforation.
4. Close lid securely to ensure wipes stay moist.
5. Scrub with textured side until grime or sealant is softened.
6. Turn wipe over and use soft side to finish clean.
